



MEMORANDUM OF UNDERSTANDING ON ACADEMIC CO-OPERATION

Between

Sharda University, Delhi NCR, India & University of Monastir, Tunisia

Sharda University (SU), Delhi NCR, India represented by its director Mr Ashok DARYANI sited Plot No. 32-34, Knowledge Park III, Greater Noida, Uttar Pradesh 201310, Inde and University of Monastir (UM) represented by its President Prof Hedi BEL HADJ SALAH sited Avenue Taher Hadded, BP 56 Monastir 5000, recognising the benefits to their respective institutions from the establishment of international link, conclude this Memorandum of Understanding (MoU).

The Memorandum of Understanding is to take effect from:

- 1 The purpose of this MoU is to develop academic and educational co-operation and to promote mutual understanding between the two academic institutions.
- 2 This MOU signifies a statement of Intent to collaborate, but is not a legally binding document.
- 3 The two academic institutions agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.
 - 3.1 Exchange of Faculty and administrative staff.
 - 3.2 Exchange of Scholars, postgraduate and undergraduate students
 - 3.3 Short term customised courses visit by students on credit transfer/study abroad programme basis
 - 3.4 Semester student exchange (exchange 5 to 10 students per semester)
 - 3.5 Conducting collaborative research projects
 - 3.6 Joint Bachelor and Master courses
 - 3.7 Online courses
 - 3.8 Exchange of PhD scholars
 - 3.9 Conducting lectures and organising symposia
 - 3.10 Internships and sabbaticals
 - 3.11 Exchange of academic information and materials
 - 3.12 Promoting collaboration in fields of mutual interest
 - 3.13 Promoting other academic co-operation as mutually agreed

The activities agreed in this Memorandum will be the subject of specific agreements and annexes and submitted to the competent authorities for agreement before signature.

The two institutions need to respect the current arrangements for the implementation of the above.

4 The development and implementation of specific activities based on this MoU will be separately negotiated and agreed between faculties, schools or institutes which carry out the specific



projects. Both institutions agree to carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.

- 5 SU and UM recognize the value of this Memorandum of Understanding to each other in promoting their programmes and activities, but any promotional material / activity which include reference to concerned countries must be sent to and be approved by the Deans of the relevant School or any other person authorized by both the institutions before use and print.
- 6 It is understood that the implementation of any of the types of co-operation stated shall depend upon the availability of resources and financial support at the institutions concerned.

Indeed, the two parts should explore the funding possibilities necessary for the implementation of cooperation agreements in accordance with available resources.

7 Should the collaborative research activities under the MoU result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.

- 8 This MoU may be amended or modified by a written agreement signed by the representatives of both institutions.
- 9 The MOU will be for 5 years in the first instance, and will be reviewed thereafter. Each party has the right to discontinue the arrangement subject to a period of 12 months' notice being given. The Understanding may also be terminated at any time by mutual consent of all the parties.
- 10 In any case of discontinuance, the parties will honour agreed commitments either via the accepted arrangement or suitable alternative negotiated at that point.
- 11 Any difference in the understanding of this agreement and in it's execution will be resolved between the two parts by amicable settlement or diplomatic ways. In case of disagreement the dispute will be resolved through the constitution of a committee made up of the two parts in order to decide in the dispute. In virtue of these agreements, both parts shall adhere to the proposals of the committe.
