



**MEMORANDUM OF UNDERSTANDING
BETWEEN
UNIVERSITY OF EAST ASIA, JAPAN
AND
UNIVERSITY OF MONASTIR, TUNISIA**



University of Monastir, Tunisia and University of East Asia, Japan (hereafter referred to as Both Universities), in order to deepen mutual rapport and advance the course of education and academic exchange, do hereby conclude the following agreements:

1. Both Universities shall co-operate for the purposes of expanding student opportunities for educational achievement and promoting academic research by instructors and researchers.
2. The aforementioned co-operation shall take the following general forms:
 - 1) Exchange of undergraduate and/or graduate students
 - 2) Exchange of instructors, researchers, and clerical staff
 - 3) Exchange of information and materials related to education and research
 - 4) Co-operation in international research and educational activities
 - 5) Co-operation in seminars and academic meetings
 - 6) Other activities deemed mutually beneficial.
3. Both Universities shall negotiate arrangements regarding the specific activities noted in number 2.
4. This MoU shall commence on the date that the final signature is affixed and be in effect for a period of five years. It may be extended through an exchange of letters with a mutual agreement no later than three months prior to the expiration of this agreement and any decision to allow this MoU to lapse will take into consideration the time needed for completion of any projects under way or any exchange visitors completing courses.
5. The term of this Agreement shall be five (5) year from the execution of this Agreement. Thereafter, this Agreement shall be extended automatically for successive periods of five (5) year each unless either party gives the other party notice of non-extension in writing at least six (6) months prior to the expiration of the original or any extended term of this Agreement. Termination of the Agreement is subject to finalisation of decided common projects and activities
6. The MoU may be terminated prior to the expiry date by either party giving a written notice six months in advance to the other party, or where an earlier termination date is mutually agreed upon.
7. Both Universities assumes any financial obligations arising from the MoU, which shall be occasionally agreed in advance by both universities.
8. The terms of this MoU may be revised at any time by an agreement between University of East Asia, Japan and University of Monastir, Tunisia. When deemed necessary, the contents of this MoU may be revised or modified at any time by a mutual agreement of both universities.



9. Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall be settled amicably through mutual consultation and/or negotiations between the Parties, without reference to any third party.


