



FRAMEWORK AGREEMENT

Between University of Monastir, TUNISIA

And Cambridge Education & Training Academy, UK

recognizes the importance of exchange and expertise in the field of education, thus aiming at improving the quality of learning and teaching in the World as a village, wishing to provide students and teachers with opportunities for studying and working in convivial international environments.

The parties:

University of Monastir, with its headquarters at Tahar Haddad Road B.P 56 Monastir 5000, Tunisia and represented by Pr. Hedi Haj Salah

And

Cambridge Education & Training Academy, with its headquarters at 128 City Road, London ECTV 2NX UK and presented by **Dr Abdoulhakem S Almhdie**

Enter into this Framework Agreement for the creation of a partnership between the two institutions. The parties hereto agree as follows

1. Objectives

University of Monastir and **Cambridge Education & training Academy** acknowledge that an international experience for students, professors, researchers and administrative personnel is integral in the positioning of a business school in the global economy. As such the parties agree to work together in the following areas of cooperation:

- a. Exchange of students,
- b. Exchange of professors,
- c. Exchange of administrative personnel,
- d. Joint research projects, conferences, and implementation,
- e. joint program development and implementation,
- f. Training of trainers
- g. Any other agreed upon activity conducive to the deepening of the relationship between **University of Monastir** and **Cambridge Education & Training Academy**.

2. Student Exchange



It is agreed that the partnership shall commence with student exchange programs between the two institutions. This shall be subject to separate appendices or specific agreements between the parties. These appendices or specific agreements shall be submitted to the supervising authorities for an opinion before signing.

The two institutions seek to explore opportunities for scholarships granted to foreign students.

3. Formal Agreements

It is acknowledged that there shall be separate Agreements for each of the items listed above which shall be included as appendices or specific agreements to this Memorandum of Understanding. These appendices or specific agreements shall be submitted to the Ministry for an opinion before signing. The parties agree to make all reasonable efforts to work together in this partnership to advance the ties between **University of Monastir** and **Cambridge education & Training Academy** .

4. Conflicts

Any difference in the understanding of this agreement or in its execution will be resolved between the two parties by amicable settlement or diplomatic ways.

In case of disagreement, the dispute will be resolved through the constitution of a committee made up of the two parties in order to decide in the dispute.

In virtue of this agreement, both parties shall adhere to the proposals of the committee.

5. Effective Dates

This Agreement shall be for a duration of 5 (five) years commencing on the date when it was signed by the last of the parties. Either party to this Agreement may rescind the above mentioned Agreement by providing twelve (12) months' notice of their intention to terminate the Agreement. Any termination shall take into account students, professors, and other personnel already involved in any activities under this Agreement and the above mentioned appendices and specific agreements.

The end of application of this agreement has no effect on projects and activities already initiated before its cancellation.
