## Cooperation Framework Agreement

### Between Dongying Vocational Institute and University of Monastir

Party A: Dongying Vocational Institute sited in 129 Fuqian Street, Dongying, Shandong Province. China, its Director Prof. Zhao YUNHUA

Party B : University of Monastir, Tunisia sited in Avenue Tahar Haddad Street B.P 56- 5000 Monastir Tunisia, its President Prof.. Hédi BEL HADJ SALAH

#### **PREAMBLE**

In order to promote educational exchanges and cooperation between China and Tunisia, establish teaching and academic bridges between universities, and improve the internationalization of their respective institutions, this framework agreement is signed after consultation and submitted to the supervising authorities for an opinion. The two parties shall cooperate in the following areas, provided that they do not violate the laws and regulations of their respective countries:

#### **Clause1 :**

- I. Exchange and training of teachers and managers of both sides
- II. Short-term and long-term student exchanges between the two parties
- III. Academic research of both parties
- IV. Integration of Chinese language and culture as elective courses into the University in Tunisia
- V. Establish joint construction of training bases and Chinese branch school in Tunisia
- VI. Other part



**Clause2:**

Specific communication and cooperation models may be further explored according to the mutual requirements of both parties to this agreement. The implementation details of the above-mentioned cooperation shall be subject to the implementation agreement negotiated by both parties and shall be submitted to the supervising authorities for an opinion before signing.

**Clause3:**

This Agreement shall be effective after signed by the representatives of both parties and shall be valid for 3 years. Within 6 months before the expiration of this Agreement, both parties may negotiate and renew this Agreement by presenting a new project between the two parties.

If either party proposes to terminate or amend this agreement during the execution period, the other party shall be notified 6 months in advance.

Without the permission of either party, neither party shall disclose, reveal, or make public any of the contents covered in this contract to a third party.

**Clause4:**

Any matters not covered by this Agreement shall be resolved through friendly negotiation between the two parties, and the specific plan and details of cooperation shall be the subject of a separate agreement or supplemental agreement presented to the supervisory authority for opinion , which shall have the same legal effect as this Agreement.

**Clause5:**

This Agreement shall be executed in duplicate, with two copies for each party. Each copy has the same legal effect.


